# Our Contributors

**Glenda Acland** is a recordkeeping consultant based in Brisbane, Australia. She is a Research Associate of the Records Continuum Research Group in the School of Information Management and Systems at Monash University, and was Research Consultant for the 1998-99 SPIRT Recordkeeping Metadata Research Project. She has had an extensive career as an archivist/recordkeeping professional operating within the records continuum model and has been employed at institutions such as Australian Archives and the University of Queensland. Since 1998 Glenda has worked in a freelance capacity as a consultant, researcher, and educator mainly for Monash University. Her professional interests include articulation of records continuum thinking, electronic recordkeeping, and enterprise recordkeeping regimes.

**Brian P.N. Beaven** has been an archivist in the Government Archives and Records Disposition Division of the National Archives of Canada since 1989. He holds an honours BA in history from the University of Toronto (1972), an MA in Canadian history from Carleton University (1973), and a PhD in history from the University of Toronto (1982), where his thesis analyzed the development and ideology of the Liberal Party of Ontario in the late nineteenth century. Since his arrival at the National Archives, he has completed twenty-six archival appraisals of federal central agencies. Since 1997, he has served as Vice-President of the Eastern Chapter of the Archives Association of Ontario, and actively dabbles in local heritage advocacy and ancestor worship in the Ottawa valley.

For many years, **Brien Brothman** worked at the National Archives of Canada, where he was responsible for textual and electronic records documenting envi-
