Norman R. Ball is Director of the Centre for Society, Technology, and Values, University of Waterloo. After graduate work in the history and philosophy of science and technology, Dr. Ball spent fifteen years in Ottawa at Parks Canada, the National Archives of Canada, and the National Museum of Science and Technology. Peter Botticelli is currently serving as Digital Projects Librarian for Cornell University. He has a master's degree, with a concentration in archives, from the School of Information at the University of Michigan. He also has a Ph.D. in the history of technology and business from the University of Illinois. He has published works on the rise of high technology enterprises in the Second World War and the evolution of trade and mass production industries in Great Britain.

Peter Bower was the founding General Editor of *Archivaria*. He is currently Executive Director of the Access and Privacy Division of the Manitoba Ombudsman's Office responsible for compliance oversight of *The Freedom of Information and Protection of Privacy Act* and *The Personal Health Information Act*. For most of the last forty years, he has been engaged in information-related activities from a variety of perspectives including news reporter, journal editor, research historian, public service and institutional manager, consultant, and professional archivist. He has spoken on and written about a variety of matters such as the built environment, historical events, archival issues, organizational and legal frameworks for the archives of several developing countries in Africa and the South Pacific, and access and privacy-related themes. He holds degrees from the University of Victoria and Dalhousie University.

Richard Brown has been an archivist at the National Archives of Canada (NA) for nearly twenty years and is currently responsible for developing the NA appraisal strategy and disposition business process for government records. He has published a number of articles and lectured extensively both in Canada and abroad on information management policy and appraisal theory. Before coming to the NA, he studied history at the University of New Brunswick, McGill University, the Warburg Institute of the University of London, and the University of Edinburgh.

Barbara L. Craig is Associate Professor of Archive Studies and Director of the Centre for Research in Information Studies in the Faculty of Information Studies at the University of Toronto. Prior to her appointment in August 1993, she was the Archivist of York University (North York, Ontario) and the Head of the Archives and Special Collections Department of the Scott Library from 1989, and an archivist at the Archives of Ontario from 1970. She has a Ph.D. in Archive Studies, has undertaken extensive research into hospital archives in Canada, the United States, and the United Kingdom, and has published widely on the history of record-keeping, the history of medicine and medical archives, and archive theory. A past Chair of the Ontario Council of Archives, an officer of the Association of Canadian Archivists in many capacities, and a Director of the Ontario Women's History Network, Dr. Craig currently is the Chair of the Canadian Council of Archives Preservation Committee, Reviews Editor of the American Archivist, and an active participant in the growing Health Archives Information Group (HAIG) in Ontario. A Canada-wide health archives information network based on a Web site and a 1-800 service is operated under her direction. Most recently she was the Theme Editor of Archivaria 41, an issue devoted to medical archives.

Kathleen Epp is an archivist with the Hudson Bay Company Archives, Provincial Archives of Manitoba (PAM) in Winnipeg. She was employed previously by the Government Records section of PAM and by the Canadian Broadcasting Corporation (CBC) of Manitoba. She holds a B.A. (Honours) in history and an M.A. in archival studies from the University of Manitoba. Kathleen was awarded the Association for Manitoba Archives Thesis Prize for 1999.

Jay Gilbert has recently taken a three-year secondment from his position with the former Government Archives and Records Disposition Division at the National Archives of Canada in order to take up a post as Archivist and Deputy Librarian with the Commonwealth Secretariat in London. He has a B.A. (classical studies and history) from the University of Victoria, a Master of Archival Studies from the University of British Columbia, and a Master of Science (public administration and public policy) from the London School of Economics.

For ten years, **Ellen Scheinberg** was an archivist with the former Government Archives and Records Disposition Division at the National Archives of Canada, until May 2000 when she moved to the University of Toronto Archives. She holds an M.A. in history from Queen's University and is currently working on a Ph.D. in history at the University of Ottawa. She has written several archival and historical articles on female textile workers, domestic servants, and case files. Her current research relates to her dissertation topic of immigrant women and Canadian deportation policy.

Ian E. Wilson was appointed National Archivist of Canada in July 1999. He has been closely associated with the development of the archival profession in Canada since the 1970s and, during the course of his long career, has served as archivist of Queen's University (1970–1976), Saskatchewan (1976–1986), and Ontario (1986–1999). He is adjunct professor in the faculties of Information Studies and Graduate Studies at the University of Toronto and is President of the Champlain Society.

Elizabeth Yakel is currently an assistant professor at the University of Michigan School of Information. Previously, she worked as research assistant for the Medical Collaboratory Project at the University of Michigan. She has also taught at the University of Pittsburgh, School of Information Sciences. Past archival positions include director of the Maryknoll Mission Archives and project archivist for the National Historical Publications and Records Commission-funded Technical Assistance Project in New York City. Her primary areas of research are electronic record-keeping systems and the evaluation of user needs. Dr. Yakel is a contributor to Vatican Archives: An Inventory and Guide to the Historical Documentation of the Holy See, the author of Starting an Archives, and several articles on the administrative use of archives.
